


Since we don't get RSVP for a head count we never know how many members will come to each event, so we ask everyone to bring a side dish. This way we have a variety of food and snacks for all that come.



Trophy for Dad

What you'll need:

- 2 foam coffee cups
- 5 inch square box (or one cut to size)
- Masking tape
- 1 gold chenille stem
- Gold craft paint
- Black construction paper, cut to fit on side of box
- White paint pen
- Scissors

• Paintbrush White craft glue

How to make it:

- 1. Turn cups upside down and trim bottom lips to make them flush.
- 2. Glue the bottoms of the two cups together.
- 3. Tape the square box shut by covering the entire box with masking tape.
- **4.** When glue on the cups have dried, wrap a piece of masking tape around the middle where the two cups meet.
- 5. Cut the chenille stem in half and insert into each side of one of the cups as trophy handles.
- 6. Cover cups completely with masking tape.
- 7. Paint masking tape on both the trophy and the box gold. Let dry.

8. Write "Awarded World's Best Dad" on the black construction paper with white paint pen. Glue to the front of the box.

9. Pipe white glue onto the bottom of the cup that does not have the chenille handles. Press onto the top of the box and let glue dry completely.

Blast from the Past Who remembers this article from the **November 2000 Newsletter**. We are looking for Neighbors who have lived here twenty /thirty years and can share more information. We would love to have photo's of the neighborhood. If you have any information please get in touch with Terry Aikens (President) The Isle of Pines Property Owners' Association, Inc. was initially formed as a temporary committee on February 16, 1958. The previous owners and developers were the Isle of Pines Company. All the rights and equities in roads, beaches, etc. would be turned over to the Association as soon as one could be formed, to put the Isle of Pines in the hands of the ones most concerned, the property owners. By October 1959, a charter and by-laws were set up and the Isle of Pines Property Owner's Association became incorporated as a non-profit organization. As a result of the efforts from the dedicated association members, many accomplishments have been made throughout the years. Going through minutes from past meetings and records, we found many achievements. The following are just a few of the major ones: Moss Park and Lake Mary Jane roads became county maintained. Association fight started for paving of Moss Park to the State Park. Rezoning approved from A-2 (Ranch and Farmland Rural) to R-1 (Single Family Residence 1959-1960-District). 1961 - Cement picnic tables were purchased and installed at both North and South beaches. 1962-Letters were sent to post office requesting mail service. Fenced in the South Beach area. Paving of Moss Park Road. 1963 -1964 -1964 - Dedication of memorial plaque at South Beach - Archie Miller. (For many years Mr. Miller had performed unlimited services for the betterment of our whole community.)
1972 - Upgraded zoning from R-1 (6,000 sq. ft. lot) to R-1 and R-IA (7,500 sq. ft. lot). Both singlefamily residence district. 1974 - (Approximate date) started regular garbage pick-up.
1978 - Finally, after a long fight with the county, Lake Mary Jane road was paved. The road had been graded on a weekly basis, but was still nearly impassable during our rainy seasons. Many vehicles graded on a weekly basis, but was still hearly impassable during our rainy seasons. Many vehicles were left later to be towed out. Zoning upgraded from R-1 and R-IA (homes east of Lake Mary Jane Road a minimum of 950 sq. ft. and homes west of the road minimum of 600 sq. ft.) to R-IA and R-IAA (Homes east 1,500 sq. ft. and homes west 950 sq. ft.) Neighborhood Watch program started. -Telephone Booster Sub-Station was obtained. At one time the phone service was very poor. The homeowners with the help of Bill Dresser (Residence Manager of Southern Bell) were able to have improved phone service. This was a considerable cost to Southern Bell, but no cost to us. -Secured the backetball court at South Beach 1979 -1980 -1982 --Secured the basketball court at South Beach. -Fought to have Capri and Roxanne Roads paved. Both were paved. -Secured barriers for end of Winterset, Fresno, Conifer and Desilu Roads for safety. -Held meeting with Sierra Club and POWER NOW to inform residents on details of OUC coal lant. -Informed residents of possible railroad crossing on Moss Park Road. Initiated formal protect to Fighting against the possible drainage of Live Oak Estates into Lake Mary Jane and Lake Hart 1984 --Fighting against the possible drainage of Live Oak Estates into Lake Mary Jane and Lake Hart. 1985 --Sold Association owned lot #117 on Capri Road. -New Park Pavilion constructed. New Park Pavilion constructed.
Purchased new entrance gate for the South Beach.
New signs for entrance to our community and the South Beach gate purchased.
Constructed two new swing sets at the South Beach.
Electrical power put in at the South Beach.
New volleyball set up at the South Beach.
New wall built to separate parking from the beach area. (South Beach)
Enlarged the Association membership to an all time high of 118 members in good standing. 1986 -Concrete floor in pavilion.
-Completion of boat ramp.
-BBQ installed at South Beach pavilion.
-Our Association joined OCHA (Orange County Homeowner's Association) primarily for a source of information and more exposure countywide. -By-laws revised: Paragraph #4 and #5.

Florida's Bicycle Laws

In Florida the bicycle is legally defined as a vehicle. Bicyclists have the same rights to the roadways, and must obey the same traffic laws as the operators of other vehicles. These laws include stopping for stop signs and red lights, riding with the flow of traffic, using lights at night, and yielding the right-of-way when entering a roadway.

There is only one road and it is up to bicyclists and motorists to treat each other with care and respect. Strict adherence to the law is the foundation for this respect.

Below is a summary of the sections of code pertaining to bicycles.

TRAFFIC LAW HIGHLIGHTS

Bicycle Regulations

A bicyclist must obey all traffic controls and signals

A bicyclist must use a fixed, regular seat for riding.

No bicycle may be used to carry more persons at one time than the number for which it is designed or equipped.

At least one hand must be kept on the handlebars while riding.

Parents and guardians must not knowingly allow a child or minor ward to violate any provisions of this section.

Every bicycle must be equipped with a brake or brakes which allow the rider to stop within 25 feet from a speed of 10 miles per hour on dry, level, clean pavement.

Lighting

A bicycle operated between sunset and sunrise must be equipped with a lamp on the front exhibiting a white light visible from 500 feet to the front and both a red reflector and a lamp on the rear exhibiting a red light visible from 600 feet to the rear.

Additional lighting is permitted and recommended.

Roadway Position

A bicyclist who is not traveling at the same speed of other traffic must ride in a designated bike lane or as close as practicable to the right-hand curb or edge of the roadway. A bicyclist may leave the right-most portion of the road in the following situations: when passing, making a left turn, to avoid road hazards, or *when a lane is too narrow for a bicycle and a car to share safely*.

A bicyclist operating on a one-way street with two or more traffic lanes may ride as close to the left-hand edge of the roadway as practicable.

Persons riding bicycles upon a roadway shall not ride more than two abreast except on paths or parts of roadways set aside for the exclusive use of bicycles. Persons riding two abreast shall not impede traffic when traveling at less than the normal speed of traffic at the time and place and under the conditions existing, and shall ride within a single lane.

Left Turns

A bicyclist intending to make a vehicle left turn is entitled to full use of the lane from which the turn is made. After scanning, signaling, and moving to the center of that lane, the bicyclist must check the signal, then proceed when it is green and safe to do so.

In addition to the normal vehicle left turn, a bicyclist may proceed through the right-most portion of the intersection and turn as close to the curb or edge as possible at the far side. After complying with any official traffic control device, the bicyclist may proceed in the new direction.

Signaling Turns

A signal of intention to turn must be given during the last 100 feet traveled by the vehicle before turning. If a bicyclist needs both hands for control, the signal need not be given continuously.

A bicyclist may signal intent to turn right either by extending the left hand and arm upward or by extending the right hand and arm horizontally to the right side of the bicycle.


Headsets

A bicyclist may not wear a headset, headphone, or other listening device other than a hearing aid when riding. Wearing a headset blocks out important audio clues needed to detect the presence of other traffic.

Civil Penalties

Non-moving violations, such as failure to use required lighting equipment when riding at night, failure to have working brakes

Moving violations, such as running stop sign or signal, riding against traffic
