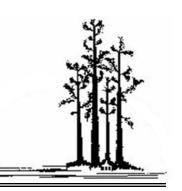

# **January Board Meeting Minutes**

Date: 1/3/2016 Start time: 7:05pm

December minutes were accepted and seconded with no opposition

Treasurers report showed a total of \$18,940.07 as of date 12/31/2016 and was read and approved. No one opposed.

### **Discussion of Old Business:**

Door to door speed hump survey is complete with 51 signatures that are interested in further exploring speed calming options. Orange County will perform a speed survey and provide further information. Orange County has begun traffic survey.

Septic tank was inspected and roots were found inside the tank. 3 quotes will be submitted to correct the issue. The issue has been resolved for \$50. Thanks Al

The basketball court was completed and is ready for use. Thanks to Dana and crew for your efforts. Thanks to the dirt backfill team as well.

January 21<sup>st</sup> is the membership drive and 2<sup>nd</sup> annual chili cook off. Invite a couple friends to attend the event. Read the flyer and enter your chili on time.

Further discussion on how to clear the north property. Kurt will talk to his contact (Gary Fishman) to discuss clearing of the property. John Rome had a quote for \$3500 for 2 pieces of equipment (and workers) for a full day. Discussion of easement, property lines, and access will need to be further investigated. There will be a questionnaire at the membership drive to find out how many people are interested and willing to help with the North park development. We would like to contact a person in the neighborhood to get a second quote. Rachel was asked to contact Gary Fishman concerning equipment he has and if he is willing to help with clearing at no charge or for free membership.

Further discussion on park trash removal. Shawn proposed acting as the sanitation engineer for the park for \$45/ month as the county will not remove park garbage. The motion was made, seconded and passed with no opposition. There was discussion of a future fundraiser and organizing a committee to help put something together. The board is seeking volunteers whom are willing to help. At this time, there isn't enough time to properly put together a spring event and maximize raised funds. We would like to further discuss putting something together and begin planning further ahead. We are looking into what needs to be done and if people are interested. Josh Starcher and Suzanne will look into setting up a PayPal account.

Shawn has put together a business proposal that support renting out the park for wedding venues as a way to raise money for IOP parties and improvements to the park. He purposes 3-5 venues per year for \$1000-1500 each event. The event would be reserved a year or more in advance. The venue would not shut down access to the boat ramp. Concerns of Bi-Laws, hosting, keys, insurance and contracts were raised. More details to come. Motion was made for Shawn to pursue a path forward. Motion was seconded with no opposition. Motion passes.

### **Discussion of New Business:**

Al submitted 3 quotes for changing locks and re-keying for the new year members. A motion was made to use Armstrong Locks for 2017 members. It was seconded with no opposition. Motion passed. The membership saved \$422.00 thanks to Al's shopping around.

A person that owns 2 lots adjacent to North Beach is asking IOPPOA to sign a contract granting an easement/access to these lots. We are investigating the contract and would like to have a more qualified person (attorney) read the contract.

If you are member of the IOPPA then you may rent the South Beach Park. How do you go about that? Well it is easy. Check out the website www.isleofpines.org and look under the Community Calendar to see if the date is available. If it is, download the Park Rental Application (Under Community Stuff). E-mail Jesse Dance at flyfshermn82@gmail.com and let him know that you want to reserve the park. Next, make arrangements to get the paperwork and your \$75 deposit check to Jesse. The park isn't considered rented until the check and paperwork have been received. Pick up the Private Function sign from Jesse on the day of your party. After the function if all is in order then your check will be returned to you.

**REMEMBER:** All garbage should be bagged and removed from the park. Park Rules are also located on the IOPPA website and should be reviewed before your function.
