Treasurers report showed a total of \$19,922.97 as of date 11/2016 and was read and approved. No one opposed.

#### **Discussion of Old Business:**

Door to door speed hump survey is complete with 51 signatures that are interested in further exploring speed calming options.

The flag pole light may need to be looked at. It was off several nights but was on during the meeting this month.

Septic tank was inspected and roots were found inside the tank. 3 quotes will be submitted to correct the issue.

#### **Discussion of New Business:**

The basketball court is currently scheduled to be completed Sunday 12/11. Stay tuned...

January 21st is the membership drive and  $2^{nd}$  annual chili cook off. People are encouraged to invite a couple friends to attend the event. Read the flyer and enter your chili on time.

Further discussion on how to clear the north property. Kurt will talk to his contact to discuss clearing of the property. John Rome had a quote for \$3500 for 2 pieces of equipment (and workers) for a full day. Discussion of easement, property lines, and access will need to be further investigated. There will be a questionnaire at the membership drive to find out how many people are interested and willing to help with the North park development.

More discussion on trash removal from the park. Several actions were assigned. More discussion to come next month...

There was discussion of a future fundraiser and organizing a committee to help put something together. The board is seeking volunteers whom are willing to help.

There were thoughts about on-line membership/ticket registration. Something like a PayPal set-up and maintenance. We are looking into what needs to be done and if people are interested.

There will likely be a soft survey during the membership drive to learn more on the wants and wishes of the POA.



- Use of facilities at your own risk.
- Beach is open from sumup to sundown except boat launching and retrieval.
- 3. Use is for members of Association and their accompanied guests only. Guests of members may not be property owners within the Isle of Pines. Members must not loan their key to a non-member for any reason.
- 4. An adult must accompany children 12 years of age and under.

<u>Bid Item</u>: Price per lawn mowing of all activities associated with lawn maintenance from February 2017 through January 2018 in accordance with the following:

- Mowing of the entire lawn at the South Beach Park and the right away from the South Beach entrance to Nell Road. This includes mowing, weed eating, blowing off debris on hard surface areas, pick up and removal of all organic debris prior to each cut, pick up and removal of all organic debris generated from each cut.
- Cutting the grass 50 feet around the Isle of Pine's sign located on Lake Mary Jane Road just north of the Country Store.

Contractor will be responsible for providing all necessary equipment and tools to perform this work. The pricing of this work is for each cut, based on approximately 20 cuts per year. The cuts will be once each month during the months of October through April and twice each month during May through September. The IOPPOA Board may request additional cuts before special events.

General Conditions: The IOPPOA is requesting bids from any person or organization interested in performing the services based on the specifications listed above. All bids must: (1) be in writing, (2) cover the calendar year 2017, and (3) include any and all required documentation specified to show proof of insurance as requested. 


