#### **First Order of Business:**

Meeting Minutes were unanimously accepted by the IOPPOA Board from the August 6, 2018 meeting.

Treasurer's Report had been sent to all Board Members by Ed Moon via email. There was an Addendum to the Treasurer's Report, as Albert Cichra dropped off an invoice for the materials he used to build the dock. The total for the dock boards was \$8,964.00, leaving us a balance of roughly \$17,500 in the bank. The Board unanimously accepted the Treasurer's Report with the Addendum.

#### **Discussion of Old Business:**

The non-motorized vessel (paddle board, canoe, etc.) storage rack is up and looks great! Thank you to Maggie Odena for organizing this project, and all of those who took the time to help build the storage rack. The Online Auction brought in about \$950. Thank you to Suzanne for getting this up and running! It was a great way to raise some extra money. Perhaps do this again in the future.

#### **Events:**

#### **Halloween:**

Wendi Rome has volunteered to chair the Halloween Party which is calendared for Saturday, October 27, 2018 from 5:00pm – 10:00pm. This is a Members Only event and it is a Potluck. Please bring your favorite main dish, side dish, dessert or ghoulishly snack. There will be a DJ spinning the tunes, a haunted cave and prizes for costumes.

New this year, it was suggested that we have a Halloween Part II which will be Trick or Trunk at the Park, and this event only will be open to the Isle of Pines Residents. The Board unanimously voted to accept this idea.

On October 31, 2018, the park will open at 4pm for residents to come down and decorate their trunk, golf cart, or set up a table to hand out treats to our trick or treaters. The trick or treating will begin at **6pm** and continue until 8pm. Park will close at 8:30 pm.

#### PRIZE FOR BEST DECORATED TRUNK





Dear Isle of Pines Residents – It has come to my attention that several residents (including myself) have recently been a victim of credit card FRAUD!

I actually received a Barclays JetBlue Visa with a large amount of credit authorized to the card. I NEVER applied or authorized anyone to send me a JetBlue Visa credit card. This has happened to at least 10 people in the neighborhood. Some folks received the actual card, and some a letter requesting that they contact the Bank to provide further information to get the card issued.

We believe some people may have received the letters and/or card, and simply thrown it away believing it was junk mail. PLEASE be very careful!! One resident was ignoring this mail and when they finally called Barclays, found the credit card issued to them had already had OVER \$9,000 charged on the card. They are disputing the charges, but it can take up to 30 days to this cleared.

What was explained to one of our residents, they believe someone has possibly gone through our mailboxes and gotten our names and addresses straight from our mailbox? Please stay vigilant!

Another resident saw a vehicle take a FedEx package that contained a credit card she knew was being delivered by FedEx. The criminals were able to intercept this card. Before she pieced the puzzle together, they had already gone to Best Buy using this card for their purchase. This is extremely serious, and if we can catch these crooks, it will be a felony charge! Mail boxes are considered Government property. Under United States Code 18 Section 1708, federal mail theft is a felony. If you are charged with mail theft, you could face up to five years in federal prison and fines of up to \$250,000.
