Old Business

- Meeting called to order at 7:09 pm.
- Motion to accept treasurer's report and accepted. No one opposed.
- Motion to accept January Minutes, accepted, no one opposed.
- Membership drive/Chili cook off was a success. To date we have 132 compared to 200 ending last year.
- The swing set in the park was repaired. A few minor parts still need replaced.
- The flag pole in the park was repaired.

New Business:

• Four positions went up for election on the executive board:

1.) President: Al Eastburn and Rick Smallish were nominated. Al declined and Rick accepted. Nikki Rock made a motion for Rick to be President and Domenique Lombardo seconded it. No one opposed.

2.) Vice President: Domenique Lombardo asked to resign as Vice President and Al Eastburn was nominated. Nikki Rock made a motion for Al to be Vice President and Suzanne Arnold seconded it. No one opposed.

3.) Treasurer: Ed Moon asked to resign. Justin Mack volunteered to serve in the position. Domenique Lombardo made a motion for Justin to be Treasurer and Suzanne Arnold seconded it. No one opposed.

4.) Secretary: Edgar Rodriguez volunteered. Suzanne Arnold made a motion for Edgar to be Secretary and Justin Mack seconded it. No one opposed.

• Community Job Bids:

1.) Newsletter Editor- one bid received by Claire Woodruff @ \$100 per newsletter. Al Eastburn made a motion to accept the bid and Domenique Lombardo seconded it. No one opposed.

2.) Lawn Maintenance-one bid received by Matt Rock Quality Lawn @ \$120 per cut with estimate of 20 cuts per year. OR \$250 a month for park maintenance including trimming, weed eat, blowing, lawn cutting, and ant pest control 9x annually and one time pressure washing. Suzanne Arnold made a motion to accept bid for \$250 per month for full service and Domenique Lombardo seconded the motion. No one opposed.

3.) Bathroom Clean Up-one bid received by Robin McAdams for \$90 a month. Includes cleaning supplies (not included soap refills, air fresheners or trash bags) 2 deep cleans, 2 spot cleans. Any act of vandalism will be an additional charge with price determined per incident. Edgar Rodriguez made a motion to accept the bid and Justin Mack seconded the motion. No one opposed.

4.) Website Maintenance-one bid received by Al Eastburn for current year membership as payment for website maintenance. Domenique Lombardo made a motion to accept the bid and Susan Arnold seconded the motion. No one opposed.

5.) Newsletter Delivery-one bid received by Al Eastburn for \$50 per month for picking up the printed newsletter from shop and home delivery. Suzanne Arnold made a motion to accept the bid and Nikki Rock seconded the motion. No one opposed.

- Nikki Rock asked about the possibility of applying for a county grant for neighborhood beautification. It is understood that IOP can use the grant to upgrade or improve parts of the community that are shared or enjoyed in the neighborhood; whether a member or not. Perhaps there is a possibility of doing something with the corner lot outside of the park entrance or the neighborhood entrance? Nikki will look into it further.
- Boat ramp sand bag repairs work organized by Shawn and Jason is on the calendar in possibly May, when the water recedes.
- Last year it was voted to look into the possibility of taking park reserves and investing them in a Vanguard account. Shawn Kraznik and Justin Mack will follow up with that and will revisit next month.
- 2021/2022 Audit/Budget Committee is needed. Justin Mack and Al Eastburn volunteered their time for the Audit and Nikki Rock and Rick Smallish volunteered for the budget committee. This meeting needs to take place before the March meeting.
- IOP Fellowship group is interested in hosting/coordinating the Easter Party this year. The date and budget was tabled until the March meeting.
- Park clean up date set for April 9th- details will be revisited for March meeting.
- Board members and Claire Woodruff will begin studying and communicating on setting up guidelines and rules for what can and cannot be advertised in the community newsletter.
- A water wash out spot runs to the lake. It has created a trip hazard. Jesse Dance will investigate and revisit with the board on a fix to divert the water.

Motion to adjourn the meeting at 8pm by Domenique Lombardo and seconded by Nikki Rock. No one opposed.

Old Business:

- Meeting called to order at 7:08 pm.
- Motion to accept treasurer's report from January was accepted (there was no Feb. treasurers report). No one opposed.
- Motion to accept February Minutes, accepted, no one opposed.
- Audit and Budget committee met for 2022, everything was accepted, no one opposed.

• Easter Party is scheduled for April 16th, budget stays the same as last year and will be organized by Faith and Fellowship group.

• Advertising guidelines was discussed, specifically concerning political ad or more specifically promoting a gathering at the park for a political candidate. It was ultimately agreed to produce the ad then have board members vote via email as to what is acceptable, while guidelines are still being structured.

• Playground is not 100% complete due to bad weather canceling scheduled workdays. Brackets still need to be installed. Justin and Rick will finish as soon as they can get together.

• The boat ramp repairs are still pending waiting on the water to recede. Keb Bazinet offered he may be able to help get construction rock donated to help with the fill in with concrete.

- The water wash-out issue will be address at the same time as the boat ramp repairs to help divert the water.
- Shawn and Justin will get together to investigate setting up reserved funds in a Vanguard account.

New Business:

- Annual Fishing Tournament is scheduled for June 19th. More info to come later.
- Annual Fourth of July party is approved and schedule for July 4th. More info to come later.

• Nickie Bazinet asked if anyone was interested in having a member of the Sheriff's Department come out to coach residence on the best practices on how to handle conflict with other residence. This would also have a Q & A time. Some members asked if we could re-establish a neighbor watch committee. It was also suggested we publish in the Newsletter, a neighborhood non-emergency # for the Sherriff's Department in lieu of calling 911 incase someone needs assistance that's not life threating. Several offerings of programs will be compiled by Nickie and shared with the board to vote on by the next meeting.

• There are occurrences where members are visiting the park and not shutting and locking the gate behind themselves. A friendly reminder of the park rules, using and or reserving the pavilion will be mentioned in the next Newsletter.

• Motion to adjourn the meeting at 7:57 pm by Buck Leahy and seconded by Domenique Lombardo. No one opposed.




