(Speaker) Dave singer:

Worried about trash in the lake, he and another neighbor Dana Aiken, called SFWM. There is a proposed new marina on the other side of the locks near the canal (formally Moreman property now Tavistock). The plan to move the locks will allow traffic into Lake Mary Jane and to Lake Hart from Lake Myrtle. This is currently restricted by the locks.

Concerns were additional traffic, usage, no benefit to Lake Mary Jane's current residents, trash, pollution etc.

No additional access to other waterways on Lake Myrtle and beyond from Lake Mary Jane. Once more information is gathered, we can discuss this further. Dave was thanked for bringing this to the board's attention.

II. Land Clearing requested by Craig Rodrique

As in years past, Craig would like to hire and pay a crew to clear the obstructed view of the lake behind his property. The company he wants to hire this year is requiring a Permit be signed by the IOPPA. This has not been requested in previous years. Conversations took place, find another company, why do we need a permit, who is responsible if once the work is completed its not in compliance, should we have Craig sign something stating if there are any repercussions he alone is responsible for making things right, not the board.

It was decided Craig will book, hire, pay for the service to clear the lake area he's requested. IOPPA will sign the permit. Area to be cleared will be marked by a board member (TBD) with tape or cones.

The board will provide a letter to Craig detailing costs, permits, fines - all expenses are Craig's responsibility.

Rick motioned for the board to approve. (I missed who seconded it) All in favor.
